Please Read the Following For Important NJ State Election Laws:

Contributor Information:

Contributions are not deductible as charitable contributions for federal income tax purposes. Guadagno for Governor may generally accept up to \$4,300 per election from individuals, corporations and PACs. Entities and individuals subject to New Jersey's state contractor "pay to play" laws may contribute only up to \$300 per election and may incur disclosure requirements as a result of doing so.

Contributions from foreign nationals (non-citizens without "green cards"), banks, insurance corporations, public utilities, cable television corporations, and certain casino interests are strictly prohibited.

Minors who are at least 14 years old may contribute from their own funds by contacting Robin Visconi at 732-833-0187.

Information for Partnerships or LLCs:

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.
